**For 2024-2025 award year, a student is automatically independent if he or she meets one of the dependency criteria listed on the Free Application for Federal Student Aid (FAFSA). Students who do not meet one of these standards are dependent by federal regulations and must include parents' information on the FAFSA form. Unusual circumstances are cases such as an abusive family environment, or abandonment by parents where attainment of parental financial documents or support is impossible.**

### Section B: Appeal Information

**If you believe extenuating circumstances exist and would like to be reviewed for a dependency appeal by the Financial Aid Office, you must explain and document the circumstances.**

**The following are NOT considered exceptional circumstances:**

- Parent(s) refusing to provide data on the FAFSA or for verification
- Parent(s) are unwilling to provide information on the FAFSA or the verification process
- Parent(s) do not claim the student as a dependent for income tax purposes
- Students who demonstrate total self-sufficiency
- Students do not reside with their parent(s)

**A student will not be independent solely because he/she is self-supporting, is unwilling to accept parental assistance, or because a parent is unwilling to provide the financial data or support. John Wood Community College will not make a student independent based on the student being declared independent by another college/university.**

### Section C: Instructions

The following documentation may be required when submitting this form:

(REQUIRED) Student statement of circumstances (be as detailed as possible – see statement directions)

(REQUIRED) Statement from a professional (counselor, lawyer, etc.) familiar with your situation.

Signed copy of your 2023 federal income tax return and W-2 forms if available

Documentation of where you lived since January 2023 and copies of corresponding bills (i.e. signed lease agreements, housing contract, utility bills, telephone bill) if available

Any supporting documents (i.e. police report, court order, etc.) if available

**Section D: Student Statement**

Explain why you should be considered independent. Your explanation should include:

- ✓ Information about your relationship with your parents and their living arrangements (location). Include the last contact you had with parents and include when, where, how, and why;
- ✓ Your current living arrangements for 2023 to current (may attach an itemized monthly budget);
- ✓ Most recent date you received support from or lived with your parents (Support includes housing, food, medical insurance, car insurance, cash, etc.);
- ✓ Explain the unusual circumstances that should make you an independent student.

**Section E: Certification – Read carefully before you sign a dependency appeal**

I certify that all information contained in this request for dependency override is true and complete. I understand that if I am found to have knowingly or intentionally given false or fraudulent statements and/or documentation, my request will be denied, and my eligibility for aid jeopardized.
